## Good Science! Symposium on Good Scientific Practice, October 10/11, 2024, Osnabrück University

On October 10 and 11, 2024, the Osnabrück University is holding its sixth symposium on good scientific practice.

- What is "good science"? What rules of good scientific practice must be observed when dealing with data and sources and when publishing research results?
- What is scientific misconduct? Where are the boundaries between scientific misconduct, technical errors and questionable scientific practice?
- What can I do if I suspect scientific misconduct?

These and other questions are the focus of the symposium, which takes place online this year. Doctoral candidates, postdocs and advanced master students, professors and lecturers at the Osnabrück University are cordially invited to participate.

The symposium will start on October 10, 2024, with an introductory lecture on the Code of Conduct of the German Research Foundation (DFG) "Guidelines for Safeguarding Good Scientific Practice". On October 11, 2024, three parallel workshops for postdocs, doctoral candidates and master students are planned, which will deal with topics such as "Dealing with Data and Sources" and "Publication Process and Authorship" from the perspective of different disciplines. In the joint final discussion on the question 'What to do in case of conflict?', procedures for dealing with scientific misconduct will be introduced.
